## COURSES AND BIRDS

- ALL STAKES -- Single course without Bird field
- All retrieving will be done on call-back. Quail, chukar and/or pheasant will be released; native game may be encountered. *No additional birds will be released in Puppy stakes.*
- A blank pistol shall be fired in all stakes *except Open Puppy and Amateur Walking Puppy.*
- Handlers and spectators are required to wear blaze orange vests in any stake where live ammunition is being used.
- Horseback handling permitted in all stakes except Amateur Walking Puppy and Amateur Walking Derby.
- Being a four-day trial, roading of dogs is permitted behind the Gallery; the full expectations and requirements are listed in *AKC Field Trial Rules and Standard Procedure* (February 2013), Procedure 6-Q 'Roading Behind the Gallery.' The judges have the authority to remove any dogs or handlers abusing this privilege during the course of a stake.

### PRIZES

- Grand Open Limited Gun Dog will be a one-hour stake. \$30 of each entry fee will go into a cash prize pool to be split 1st 40%; 2nd 30%; 3rd 20%; 4th 10%. Amateurs may enter and can accept any cash winnings without compromising their amateur status.
- The Patrick Cooke Memorial trophies will be awarded to the winners of the Open Limited and Amateur Limited Gun Dog stakes (to be returned before the Spring trial 2018); the Saul Himmelfarb Memorial trophy will be awarded to the best Vizsla in the Amateur Walking Puppy stake (to be returned before the December trial, 12/2/2017).
- Standard AKC rosettes will be presented to 1st – 4th place, and Judges Award of Merit may be presented if applicable.
