COURSES AND BIRDS

- There will be concurrent stakes. Please have an alternate handler available in case of course conflicts.
- The 5 minute-to-the-line line rule will be strictly enforced.
- All retrieving will be done on call-back. Quail, and/or chukar will be released; native game may be encountered.
- Horseback handling is **NOT** permitted.
- A blank pistol shall be fired in all stakes except Open Puppy and Amateur Puppy.
- Handlers and spectators are required to wear blaze orange vests in any stake where live ammunition is being used.
- There will **NOT** be a wrangler at this trial. We will have a tractor-drawn gallery wagon for spectators during this event, weather permitting.

FOOD
